## Conditions of participating in the conference

1. Participating in the conference is free of charge, and the accepted papers would be published in Twejer Journal or The Academic Journal of Nawroz University.
2. The research should be sent in soft format (WORD and PDF) to [conference.law@soran.edu.iq](mailto:conference.law@soran.edu.iq).
3. The first page of the research should contain the following information:
  - a) Title of the research.
  - b) Name of the researcher or researchers.
  - c) Scientific title.
  - d) Place of work.
  - e) Email.
  - f) Telephone number.
4. The abstract should be in the language of the research and should not exceed one hundred words.
5. Keywords should not exceed six words.
6. Research topics should be listed as follows.
  - 1- Title of the research.
  - 2- Introduction.
  - 3- Content.
  - 4- Conclusions and (suggestions, if any).
  - 5- footnotes.
  6. references.
  - 7- Appendix (if any).
  - 8- Abstract of the research in two different languages.
7. The page layout should be set up as follows:
  - a- Page size should be A4
  - b. Margins: 2.5 cm space for all sides of the page.
  - c. references should be at the end of the research, not at the end of the page. It should also be manual, not automatic.
  - d. The space between lines should be 1.15 cm.



e. The space after the paragraph should be six points and the space before the paragraph should be zero.

f- The first word of the paragraph should be 1 cm and automatic.

g- Unicode should be used for writing as follows: Unikurd Goran font for Kurdish, Times New Roman font for Arabic and Times New Roman font for English.

8. The font size should be as follows:

Title	Arabic and Kurdish languages	English
Main Title	16 Bold	14 Bold
Sub-title	14 Bold	12 Bold
Content	14	12
Footnote	12	10

9. footnotes and references should be recorded in Harvard style, as follows: (title, year of publication, page number).

10. Sources should be listed alphabetically and do not need to be numbered or punctuated.

11. Maps, photos and graphs should be in JPG format and the area should not exceed 11 \* 18 cm and the quality of the photos should be high.

12. The page number should be in the middle and at the bottom of the page.
